IV. Reports

a. Treasurer's Report (5 min)

- \$5500 spent on Musky Habitat Project (staffing)
- \$295,517 ending balance as of August 24, 2023 (including asset values)

b. Committee Reports (40 minutes total time allowed to cover all committee discussions)

i. Clean Boat Committee – 5 Minutes

- 14,641 observations with iLids camera at Chicago Bay ramp as of August 18, 2023
- 261 hours logged for ramp inspection/monitoring as of August 18, 2023

ii. Fishery/Water Safety Committee – 5 Minutes

- Permits are pending approved for AquaThrusters.
- Mike Persson met with Max Wolter in Musky Bay to begin (assembling equipment/preparing) for the project.
- October 1, 2023, is the targeted start date.

iii. Eco-Harvester Committee – 10 Minutes
